

Privacy Policy art.13 GDPR 679/2016

AUTOMA S.R.L., as data controller, informs you, pursuant to Article 13 of the GDPR 679/2016, that the data you provide us with may be processed, in compliance with the above-mentioned legislation and the obligations of confidentiality.

Processing of personal data means its collection, registration, organisation, structuring, storage, adaptation or modification, extraction, consultation, use, communication by transmission, dissemination or any other form of provision, comparison or interconnection, restriction, deletion or destruction of data even if not registered in a database.

We would also like to inform you that your personal data will be processed in compliance with the methods indicated in Article 5 of the GDPR 679/2016 which provides that the data shall be processed lawfully, correctly and transparently in respect of the person concerned; collected for specified explicit and legitimate purposes and subsequently processed in a way that is not incompatible with those purposes; adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed; accurate and, if necessary, updated; kept in a form which permits identification of the persons concerned for no longer than is necessary for the purposes for which they are processed; processed in such a way as to ensure appropriate security of personal data, including protection, by appropriate technical and organisational measures, against unauthorised or unlawful processing and against accidental loss, destruction or damage.

Purposes and methods of the processing for which the data are intended

These data will be processed in relation to contractual requirements for the fulfilment of legal and contractual obligations deriving therefrom, in order to allow a more effective management of professional relationships.

Legal basis of processing

The provision of data is compulsory for everything required by legal, fiscal and contractual obligations.

Period of conservation

Your data will be stored for 10 years as required by law.

Recipients or categories of interested parties

Without prejudice to the communications made in execution of legal and contractual obligations, the data may be communicated only in Italy for the sole purpose of better management of the respective rights relating to the individual contractual relationship.

The data provided may be communicated, where required by law or secondary regulations, to external parties who carry out specific tasks on behalf of the company, to banking institutions for the management of collections and payments arising from the execution of the contract and processed by our internal staff as persons authorised to do so.
